1	Whether to consider the request of untrained ST teachers who are appointed in the year 2000 and prior to 2000 to consider them for promotion to the School Assistant post by taking their date of joining in the lower cadre though they have been initially appointed as Untrained teachers/Special VVs.	The teachers who were appointed without training qualifications and who acquired requisite qualifications in later period, their service/seniority shall be counted from the date of acquiring requisite qualifications to hold the post.
